2. Each Vendor will be provided with a 10x10 Tent, one-8-foot table.
3. Only pre-approved food and/or beverage items may be sold by the vendor at the event.
4. No generators are allowed. No open flames. *(strictly enforced)*
5. Vendor is required by Florida State Law to provide your own fire extinguisher.
6. Vendors are required to provide proof of liability insurance in the form of a Certificate of Insurance with the following 3 entities listed as an 'additional insured' on the COI: Pensacola Beach Chamber of Commerce, Santa Rosa Island Authority, and Escambia County.
7. A minimum of one trash can is required. Vendor is responsible for all trash removal.
8. Vendor is responsible for all clean-up, trash and removal of any items brought to the event.
9. Vendor must comply with all Florida Department of Health requirements.
10. Vendor is responsible for own ice supply, if needed.
11. All Vendors must post prices.
12. ELECTRICITY - Advanced notice & approval is required for use of electricity. Contact Jessica Simpson for electricity needs (jessica@visitpensacolabeach.com). Failure to do so will result in no power.
13. Vendors will receive parking passes on their vendor spot and must be set up by 7:00am both days.
